Lester "Toby" and Colleen Hooben are the owners of Riverbend Estates. They bought the property a year and a half ago and live next door to the property. The Chairman opened the discussion to the residents. Michael Laliberte 2 Admiral's Way stated he had spoken previously to the ZBA Secretary and Toby and suggested to have a meeting with everyone to answer a few questions about the property. He wanted to know what they had in mind to do with the property and what were the obligations of the owner and the residents. He was also wondering about finishing the paving of the road, fixing the sidewalks, and removal of the Riverbend Estates sign out front by the road. Toby said he would remove the sign tomorrow. Mr. Laliberte also asked about snowplowing and said Keith McCartney usually mows the grass and does other landscaping. Barbara Miller of 11 Admiral's Way asked what were the plans of the property. Keith McCartney 8 Admiral's Way asked had questions about the road. Toby said he still is not sure what the plans of the property are as of yet, he has an attorney looking into all of his options. M. Oliveira stated a lot of the property is wetlands, how do you develop, not much can be done. Toby told everyone he owns the property all the way to the river.
