3. 32 Forrest Street

John Garanito appeared before the Board with septic plans. The Septic Plans were reviewed by our consultant Nyles Zager. The Board reviewed the comments and the plans. The Board approved, stamped and signed. The plans will be held until the fee of \$375.00 is paid for the Septic Permit.
