Pursuant to Article 1, Section 2, of the General Bylaws of the Town of Berkley, the Board of Selectmen will hold a public hearing on **Wednesday**, **May 21**, **2025**, **at 6:35 p.m.** in the Moitoza-Pettey Hearing Room at Town Hall, One North Main Street, Berkley, Massachusetts, regarding proposed amendments to the General and Zoning Bylaws as follows:

ARTICLE 13:

To amend Article 27 of the General Bylaws, "Capital Improvement Planning Committee," by:

- 2. Removing the prohibition on members holding other Town positions;
- 3. Raising the project threshold for capital consideration from \$5,000 to \$10,000;
- 4. Eliminating the requirement that a capital project be referenced in the Committee's report before appropriation;
- 5. Clarifying language by relocating a sentence on quorum requirements.

ARTICLE 15:

To amend the Zoning Bylaw by:

- 1. Updating the Table of Use Regulations (Section 3.2, Item A.2) to allow two-family dwellings in all residential and business districts by Special Permit from the Board of Selectmen;
- 2. Revising Section 4.2.2 to apply minimum lot area requirements (65,340 sq. ft. per unit) to all two-family and multifamily dwellings.

ARTICLE 16:

To amend the Zoning Map by rezoning the following parcels to General Business:

- i. 33 Padelford St. (Map 10 Lot 36-01)
- ii. 35 Padelford St. (Map 10 Lot 60)
- iii. 35R Padelford St. (Map 10 Lot 61)

ARTICLE 19:

To amend Article 1, Section 2, of the General Bylaws, "Validity of Bylaws," by deleting the requirement that a public hearing be held by the Board of Selectmen at least ten days prior to presentation of bylaw changes at Town Meeting.

Pursuant to Article 1, Section 2, of the General Bylaws of the Town of Berkley, the Board of Selectmen will hold a public hearing on **Wednesday, May 21, 2025, at 6:55 p.m.** in the Moitoza-Pettey Hearing Room at Town Hall, One North Main Street, Berkley, Massachusetts, regarding proposed amendments to the General Bylaws as follows:

A new proposed bylaw, titled "Berkley Noise Law," was submitted in writing by ten or more registered voters of the Town. The petition seeks to adopt the proposed "Berkley Noise Law," which establishes limits on excessive, continuous, or plainly audible noise originating from both stationary and mobile sources within the Town. The bylaw outlines specific prohibited acts, including sustained noise from amplified sound systems and certain motor vehicles, and provides for exemptions (e.g., agriculture, construction, municipal events). Violations are subject to enforcement by the Select Board or Police Department and may incur escalating fines. The complete text of the proposed bylaw is on file and available for public review at the office of the Town Clerk.
