# **Finance Committee**

# **Town of Berkley Annual Report**

This Fiscal Year 2022 Budget has been a very challenging process with the continued COVID-19 pandemic and all it's challenges. Trying to maintain the current level of service to the community and our stakeholders the taxpayer. This years budget does that with an infusion of available funds as it was done with the Fiscal Year 2021 budget but with a smaller amount.

The total proposed budget for FY22 is 20,559,530 an increase of 535, 106 or a 2.67% increase from FY 2021.

Summary of the Finance Committee's budget recommendation for Fiscal Year 2022 include:

- 1. Overall the Budget increased by 2.67% or 535,106 from FY 2021.
- 2. Revenue for FY 22 is proposed at 21,509,491 an increase from 21,460,171 from FY2021 a difference 49,320.
- 3. Fully fund the Somerset Berkley Regional High School District budget request of \$2,552,594 a decrease of 131,871.
- 4. K-8 Budget is 8,206,952 from 8,086,312 an increase of \$120,640 or a 1% increase.
- 5. Bristol Plymouth Regional Technical High School assessment increased from 805,960 to 991,871 an increase of 185,911 or 23%.
- 6. Bristol County Agriculture High School assessment increased from 26,587 to 72,451 and increase of 45,864 or 173%
- 7. Funding for additional Fireman/Paramedic
- 8. Library fully funded, 4<sup>th</sup> year in a row.

- 9. Contractual Obligations and 2% increase to all elected officials.
- 10. Removed funding for Assessors Clerk.
- 11. No Police Cruiser for this fiscal year.

The Financial Advisory Committee met and approved the following items from available funds, also known as Free Cash. (1,667,516.00)

The Finance Committee feels we have addressed the needs that this community deserves from the Municipality, Police, Fire, Highway our Veterans and our seniors. We have invested in our K-8 education, Bristol Plymouth Regional Technical High School, Bristol County Agricultural High School and Somerset Berkley Regional High School are funded. There are some areas of concerns as the town of Berkley moves forward. This was the 2<sup>nd</sup> straight year that available funds were used to supplement our budget. FY 2021 a total of 368,093 was used and in FY22 a total of 305,530 was used a difference of 62,563. This can be attributed to the following factors, minimal increases to Chapter 70 state aid (schools), minimal increase to state aid, marijuana mitigation monies that haven't materialized during the Covid-19 period, slower increase of new growth through the assessor's office and continued collective bargaining increases and municipal modernization. This also includes state mandated unfunded mandates such as OSHA requirements and Police Reform. The future will have some Capitol Projects that the taxpayer must be aware of such as, improvements to the Community School, future renovations at Bristol Plymouth Regional Technical High School and the continued improvements to the Bristol County Agricultural High School. The Finance Committee members in attendance at the May 25, 2021 meeting unanimously voted to support Articles, 2,3,4,5,6,7,8,9,10,11,12,13, and14 on this year's warrant.

**Article 2** Selectman Larabee made a motion and it was seconded that the Town transfer and appropriate from available FY21 funds the following amounts:

Article 3 Selectman Cochrane made a motion and it was seconded that the Town vote to accept the fourth paragraph G.L c. 41, §111F, to create a special fund to be known as the Injury Leave Indemnity Fund, to be expended by the Board of Selectmen without further appropriation for payment of injury leave compensation or medical bills incurred under G.L. c. 41 §111F or §100, to which appropriations may be made, and amounts received from insurance proceeds or restitution for injuries to firefighters or police officers shall be credited, provided further that said Board may, if the amounts therein are not immediately necessary or required in the foreseeable future, release specific amount to the General Fund.

Some discussion from the floor asking why this is going into a general fund and not a trust fund.

Call for vote, Motion carried unanimously

Article 4 Selectman Miller made a motion and it was seconded that the Town vote to approve the Somerset Berkley Regional District Amended Regional Agreement, as presented by the School Committee, dated April 27, 2021, on file at the Berkley Town Clerk's Office, Superintendent of Schools' Office and Berkley Public Library, and posted on the Town's website and the District's website (www.somersetberkley.org), where the adoption of such Amended Agreement is subject to approval by both member towns as well as the Commissioner of Elementary and Secondary Education.

**Amended**, Jennifer Andrews, Somerset-Berkley School Committee read the changes to the amendment as follows:

The Somerset Berkley Regional Agreement was first adopted on June 21, 2010. In October 2020, a Regional Planning Board was established to review the agreement in its entirety and to make recommendations for amendments. The Amended Agreement language, including the Alternative Assessment Methodology described therein, has been developed by the members of said Regional Planning Board in consultation with DESE officials and was approved by the Regional School Committee at its meeting on May 14, 2021. A summary of the proposed amendments along with the Amended Regional Agreement in its entirety has been made available to the public for their review on file at the Town Clerk's Office, Superintendent of Schools Office and the Berkley Public Library as well as being posted on the Town's website and the District's website (www.somersetberkley.org).

The proposed amendments include general updates to the original Regional Agreement that delete references to the Transition Plan and Interim Period which are no longer relevant; the deletion of references to staggered terms for elected officials used at the start of the region which are no longer relevant; the deletion of references to the former Somerset High School building and sale of the land to the District; updating language relative to the Budget Development process to be line with M.G.L. and State Regulations, including adding language relative to amendments to approved budgets. The Amended Agreement also details both the Statutory and the Alternative Assessment Methodologies which may be used to allocate the annual operating and capital expenditures between the two member towns.

The Alternative Assessment Methodology or formula detailed in the Amended Agreement is based on the State-determined Minimum Local Contribution for each member town and apportionment of all the costs in excess of the Minimum Local Contribution allocated on a per pupil basis, with the exception of the Net Out-of-District Special Education Tuition costs which are assessed to each member town based on the actual costs incurred on behalf of all current and incoming high school students who are residents of said member town for the year for which the budget is being prepared. This Alternative Assessment Methodology more fairly allocates the expenses associated with costly Out of District Special Education Tuitions to the members based on the costs incurred on behalf of students residing in their respective towns while allocating all other costs in excess of the state determined Minimum Local Contribution on a per pupil basis. Upon approval by both member towns, the Amended Agreement will then be submitted to the Department of Elementary and Secondary Education for approval by the Commissioner.

Called for vote, motion carried unanimously

**Article 5** Selectman Larabee made a motion and it was seconded that the Town vote to raise and appropriate, and transfer from available funds, or otherwise provide for the payment of the outlays of the following town departments for the ensuing twelve (12) month period through June 30, 2022 all as set forth in the budget presented by the Finance Committee:

Article 9 Selectman Cochrane made a motion and it was seconded that the Town vote to authorize expenditure limitations for the following revolving funds pursuant to G.L. c. 44, § 53E½, for the fiscal year beginning July 1, 2021, to be expended in accordance with Article 35 of the General Bylaws: wiring inspector, \$10,000; gas inspector, \$10,000; plumbing inspector, \$10,000; Board of Appeals, \$5,000; Planning Board, \$10,000; Soil Conservation Board, \$5,000; Board of Health, \$60,000; Police Department, \$200,000; School Department, \$60,000.

No discussion, motion carried unanimously

**Article 10** Selectman Miller made a motion and it was seconded that the Town vote to authorize the Board of Selectmen to accept and enter into contracts for the expenditure of any funds allocated by the Commonwealth and/or federally aided programs for the construction, reconstruction and improvements of Town Roads.

No discussion, motion carried unanimously

**Article 11** Selectman Larabee made a motion and it was seconded that the Town vote to authorize the Board of Assessors, in accordance with Massachusetts General Laws, Chapter 41, Section 4A, to hire one or more of its members to do annual tax maintenance on real and personal property and to set the fee paid to said

members at \$15.00 per parcel, said funds to be paid from Annual Tax Maintenance Account.

No discussion, motion carried unanimously

**Article 12** Selectman Cochrane made a motion and it was seconded that the Town vote to accept the provisions of Ch. 126 of the Acts of 1988, amending Sec. 4 of Ch. 73 of the Acts of 1986, to allow an additional exemption which shall be for all exemptions and none of which shall exceed 25% of said exemption for which they qualify in Fiscal Year 2022

Moderator, John Blake explained the meaning of this MA General law. No further discussion, motion carried unanimously

Article 13 Selectman Miller made a motion and it was seconded that the Town vote to authorize the Board of Health, in accordance with Chapter 41, Section 4A, to appoint one or more of its members as agents of the Board of Health as well inspectors and sanitation inspectors and to set the dollar amount for said agents' Inspector fees as follows: \$75.00 per perc hole, \$100.00 per well inspection, \$150 per sanitation inspection, \$75.00 per food service inspection, \$50.00 per pumper truck inspection, \$75.00 for other miscellaneous inspections when a license or certificate is required.

No discussion, motion carried unanimously

**Article 14** Selectman Larabee made a motion and it was seconded that the Town vote to file a Home Rule Petition with the General Court for a special law authorizing the Town to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises to Berkley Beverage Corp., d/b/a Bristol Country Wine & Spirits, with the text of such proposed Special Act to substantially as printed in the 2021 Annual Town Meeting warrant.

No discussion, motion carried unanimously

**Article 15** Selectman Cochrane made a motion and it was seconded that the Town vote to amend Article 23, Personnel Bylaw, to add a new subsection 8 as follows:

**SECTION 8.** Appointments. Unless the mode of appointment is otherwise provided by law, the Board of Selectmen shall appoint employees of the Town, provided however, a committee consisting of the Board of Selectmen, the Town

Administrator, and the Department Head over whom the employee will be supervised, shall first meet to submit a recommendation to the Board. All such recommended appointments shall become effective as Board of Selectmen appointments on the fifteenth (15<sup>th</sup>) day following the day on which such notice of recommended appointment is filed with the Board of Selectmen, unless the Board of Selectmen shall, within that period by a majority of all of its members, vote to reject such appointment, or has sooner voted to affirm it;

And further to renumber the existing section 8 and delete section 9.

Town Council, Adam Costa explained the reason for the changes. No further discussion, motion carried unanimously

**Article 16** Selectman Miller made a motion and it was seconded that the Town vote to adopt a non-binding resolution supporting the regionalization and integration of the Town's kindergarten through eighth grade, a.k.a. K-8, educational program(s) and curriculum with the Town of Somerset.

Selectman Miller explained that this would just be a study and wanted to give the voters an opportunity to provide input. Jennifer Vincent, Somerset Berkley School Committee supports the study and explained that this was non-binding for the town and would be paid for by a grant received from the Town of Somerset.

Selectman Larabee supported a yes vote. David Patrick, Berkley School Committee member did not support it. It was explained by the Moderator that a yes vote would carry the study and a no vote would not support it. Jennifer Vincent called for a vote, motion was defeated nearly unanimously

Article 17 Cherise Hoak, resident voter, made a motion and it was seconded that the Town vote to Amend the Town's General Bylaws by adding the following as a new section to Article 4 of the General Bylaws:

No member of the Board of Selectmen shall hold any other elected or compensated office with the Town of Berkey during his or her term as Selectmen; nor shall any former Member of the Board of Selectmen hold a position or employment, or compensated appointed office of the Town, within one (1) year following his or her term as Selectman.

Cherise Hoak further explained the reason for the citizen petition and presented a spreadsheet with comparisons from other towns. Selectman Miller was not in support of this and further explained that this would jeopardize a persons right to vote. After much discussion from the floor the article was motioned and seconded

to table. The moderator explained the yes vote and no vote to table the article. Vote needed, simple majority, motion to table passed, nearly unanimously.

**Article 18** Cherise Hoak, resident voter, made a motion and it was seconded that the Town vote to Amend the Town's General Bylaws by adding the following as a new section to Article 4 of the General Bylaws:

No person shall serve more than two (2) consecutive three-year terms on the Board of Selectmen. This provision shall apply to the Members of the Board of Selectmen presently serving at the time of adoption of this Bylaw.

Cherise Hoak explained the reason for this petition and added that she thought there should be term limits for the Board of Selectmen both serving now and in the future. Selectman Miller did not support the article and said it would take away a persons right to vote. Town Council also explained that there were some issues as to the way the Bylaw was written that could potentially pose a problem with executing it and that it would need to be approved by the Attorney Generals office for final approval. After much discussion from the floor the article was motioned for a vote and defeated nearly unanimously.
