Donna Kinsman – Miller noted that the Board usually defers decision making to the Dept. Head and that this is just a meet and greet kind of thing. Miller asked why she applied, Kinsman stated she has strong experience and felt like her background would fit the position. She lives in East Taunton. Miller asked if there was any reason she wanted to leave her current position. Kinsman stated she has been there a long time and wanted a change. 2. Rachel Nickelson – Miller asked where she lives. Rachel replied in Westport. Miller asked what made her apply here. She stated that she audited in this area and did municipal worked for the Town of Yarmouth, she wants to get into the work rather than just looking at it. She loves small towns and worked 20 hours per week on the budget for the last project and then it got cut so it went down to 12 hours. Only wants part time work, not full time it's the perfect number. Miller stated she has very applicable skills and experience. Cochrane questioned that there might be more than 20 hours during the FY end could she do more than 20 hrs. Rachel stated yes she could. Appointments & Old Business	<ul style="list-style-type: none"> - Board met with SMHG regarding the Town's health insurance. Kate Sharry gave a presentation to the Board. Sharry stated in her presentation that they have 1700 active subscribers, just partnered up with Canna RX which helps subscribers get a 90 day supply of meds for 0 copay sent to them, the average increase of all plans is usually 3.5%, everyone has a vote, and that there was a vote recently regarding the Joint Purchase Group that made it so that Town's that put money in and choose to leave will not be able to get that money back. Joe Freitas stated that he felt it was disingenuous to have voted on that just before the decision to pull out had to be made, and that it could have waited until January. Sharry noted that it was in the works for over a year now. Sterling questioned MIIA reps that were present and SMHG. Sterling wanted to know why MIIA was able to let the Town know what the rate for the upcoming year would be, yet SMHG did not. Joe Callahan and Kerri Pochay of MIIA stated that their Board votes at a meeting and they try to vote in a timely manner so that when the Town's go to Town Meeting they can budget for it. And that because they have 128 Cities & Towns they have a dedicated underwriter. - The Town Administrator and the Board went over a letter from MIIA regarding updated property valuations. Mr. Coutinho noted that this has been put off for years and now needs attention. The current values for the schools were significantly under the real values at only \$19 million on both buildings. Increase suggested is \$30 million to replace as it is \$232/sqft to replace. Berkley Middle School alone is 232 sqft. Miller wanted to make inquiries to get other rates. Cochrane stated that the Town schools are under insured you can't build a school for \$8 million. Sterling would like to see what other Towns have for rates per sqft for their commercial schools. Mr. Coutinho stated he will take care of it.

Town Administrator's Report


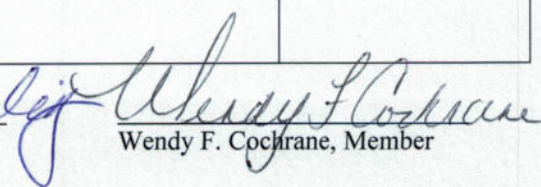
