6:05pm - - Marcus Baptiste opened the 40A Public Hearing for Sardinha Family Trust/
Dunkin Donuts/ Poyant Signs. 128 Myricks St. Map 23 Lot 5 requesting a variance for
internally illuminated signs. The newspaper ad ran in the Taunton Daily Gazette 11/20/21
& 11/27/21. All certified mailings were returned back from the abutters.
Bill Gavigan from Poyant Signs 125 Samuel Barnet Blvd. New Bedford, MA 02745 came
in front of the Board. No abutters were present.

Mr. Baptiste presided. The petition, plan, and the submissions were reviewed by the
Board.

Mr. Gavigan introduced himself to the board. Dunkin Donuts 128 Myricks St. has gone
through a full remodel. He came to the Board for a variance to illuminate most of the
signage. Dunkin Donuts has always had illuminated signs but due to the new By-Laws
they now need a variance for all internally illuminated signs. All the businesses in the area
have illuminated signs. He feels they need the illuminated signs to be competitive in the
area. He explained all the signs that are on the property. The Board went through the
plans with Mr. Gavigan. All the signs are new. It is all the new branding of the company,
they are a classier better looking sign. The previous signs were in the same locations
already internally illuminated, they are just new signs put into the same spot. The signs
are shut off until the hearing per the Building Inspector, after the hearing the signs can be
lit. He told the board basically all the signs just changed their graphics. T. Carmo asked if
the Drive-Thru canopy had any lighting. Mr. Gavigan said yes there are 2 recessed lights
they are 4 in. halos. J. Russo asked if there have been any concerns from the neighbors.
Mr. Gavigan said he has not heard from any neighbors it has been an existing business.
Also no neighbors present at the hearing. J. Russo made a motion to close the hearing. T.
Carmo seconded. The Board further discussed. The Chairman stated basically the
lighting is just upgrading to their new logo. Need a variance due to the By-Laws for
internally illuminated signs. T. Carmo made a motion to grant the application as
presented. J. Russo seconded.

All Motioned the next meeting date to be determined


