**AGENDA ITEM #7: ADMINISTRATIVE & SCHOOL COMMITTEE REPORTS****AGENDA ITEM #7a: SOMERSET BERKLEY REGIONAL SCHOOL COMMITTEE**

At the upcoming meeting on Thursday, the preliminary budget and the regional planning study results will be further reviewed. The high school is moving through an accreditation process. The Little Mermaid production will be held in April.

**AGENDA ITEM #8a: COVID/DESE PROTOCOLS**

DESE and DPH "strongly recommend students and staff continue to follow the DESE-DPH Protocols." After discussion, the School Committee agreed to continue to support the district's current status to "strongly recommend" and not require wearing of masks for individuals who test positive. Berkley's numbers remain very good at this time, with only one positive case since returning from vacation. The Committee agreed they are comfortable with the current protocol and did not feel the need to vote a change.

Acceptance of Resignation of Instructional Personnel #3475, Student Teachers and Interns #3490, Physical and Mental Health Examinations #3510, Professional Growth for Teachers #3800, Dismissal of Professional Staff #3940, Retirement of Professional Employees #3990, and to delete Application for Position #3420, Limit on Agency Fee #3435.

**AGENDA ITEM #8c: STUDENT TRANSPORTATION, 2022/23**

Mrs. Ryan reported that for next school year, middle school bus stops will be changed to group stops. A group will be formed to review bus lists to determine new group stops. The timeline is to complete this by April vacation so bus routes can be shared with families. An appeal process will be available for families to request a bus stop change; this will be allowed only for safety issues. Once these routes are established and the appeal deadline passes, no bus stop change requests will be accepted. New start/end times for school next year and group bus stops will give afternoon buses more time to get to BCS for afternoon pick up.

**AGENDA ITEM #8d: SCHOOL DEPARTMENT BUDGET 2021/22**

It was moved by Mrs. Solomon, seconded by Mr. Fagan and VOTED to approve the budget transfers as presented.

**AGENDA ITEM #8e: PROPOSED SCHOOL YEAR CALENDAR, 2022/23**

Mrs. Ryan reviewed Draft #1 (#2 no longer is an option). We recently learned that the state primary is Tuesday, Sept. 6, the same day as the first day of school for students in grades 1-8. Also, November 8 is an election day; however, voting numbers are expected to be light both days. Staff PD is scheduled for Thursday and Friday, September 1 and 2. Mrs. Ryan reviewed the new start/end times.

It was moved by Mr. Fagan, seconded by Mrs. Solomon and VOTED to approve the school year calendar (Draft #1) for 2022/23 as presented.

A video was shown that provided additional information on the Capital Improvement Plan & Reserve Fund request from READS Collaborative.

It was moved by Mr. Fagan, seconded by Mrs. Solomon and VOTED to approve the reasons for the READS Collaborative Capital Reserve Fund as presented and the limit of \$4,000,000 on the amount that may be held in reserve.

The bid summary of custodial supplies was circulated.

It was moved by Mrs. Solomon, seconded by Mr. Fagan VOTED to approve the custodial supplies bid for 2022/23 as recommended: Land-Tek: #5, 8, 9, 13, 19, 20, 21. Pyramid: #2, 11, 15, 22. Top Notch Supply: #6, 10, 12, 14, 16, 17. WB Mason: #1, 3, 4, 18.

**AGENDA ITEM #9d: PRESCHOOL PROGRAM RATES, 2022/23**

Berkley's Preschool rates have not increased in over ten years and are the lowest in the area. Mrs. Ryan reviewed the proposal to increase the rates for the three Preschool programs we offer. The number of payments would increase from five/year to seven/year which makes the impact on the monthly cost minimal. It is recommended that the 2-day program increase to \$1100/year, the 3-day program increase to \$1500/year and the 5-day program increase to \$2200/year. She also reported that we are looking into establishing a sliding fee scale for families that need assistance and a voucher system through PACE. She recognized Mrs. Porter and Mrs. Cogar for all their work on this proposal.

It was moved by Mrs. Solomon, seconded by Mr. Fagan and VOTED to approve the Preschool Program Rates as presented.

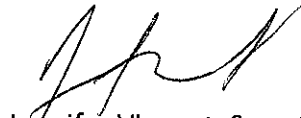
