THE TAUNTON MUNICIPAL LIGHTING PLANT

requests permission to locate poles, wires and fixtures, including the necessary sustaining and protecting fixtures to be owned and used in common by your petitioner, along and across the following public way:—

ELM STREET

- One (1) new sole electric pole location; EL28-S

Wherefore we pray that after due notice and hearing as provided by law, we be granted identical locations for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as we may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked—THE T.M.L.P., No. 020325

Your petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.

ORDER FOR ELECTRIC LIGHT POLE LOCATIONS.

Notice having been given and a public hearing held, as provided by law, IT IS HEREBY ORDERED:

that THE TAUNTON MUNICIPAL LIGHTING PLANT

be hereby granted locations for and permission to erect and maintain poles and wires to be placed thereon, together with such sustaining and protecting fixtures as said Company may deem necessary, in the public way or ways hereinafter referred to, as requested in petition of said Company dated the

3rd day of February 2025

All construction under this order shall be in accordance with the following conditions:-

Poles shall be of sound timber and reasonably straight, and shall be set substantially at the points indicated on the accompanying plan filed with this order. There may be attached to said poles by said TAUNTON MUNICIPAL LIGHTING PLANT necessary cables, wires and fixtures and all of said wires and cables shall be placed at a height of not less than

16 feet from the ground.

The following are the public ways or parts of ways along which the poles above referred to may be erected, and number of poles which may be erected thereon:—

ELM STREET

- One (1) new sole guy pole location; EL28-S
